

**ANNUAL LITTLETON FESTIVAL
ROAD CLOSURE
ORDINANCE
O-2018-02**

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWN OF LITTLETON that the following section is adopted as Annual Littleton Festival Road Closure Ordinance to be included in the Code of Ordinances, Town of Littleton Title VII: Traffic Code.

- 1. The Code of Ordinances, Town of Littleton North Carolina, is hereby amended by adding a section to be numbered 70.01 and it shall read in its entirety as follows:**

70.01 General Provisions

(A) The Board of Commissioners of the Town of Littleton pursuant to the authority granted by G.S. 20-169 does hereby declare a temporary road closure during the date and time set forth below on the following described portion of a State Highway System route:

Date: Thursday, August 30, 2018

Time: 6:00 p.m. to close the outer two lanes of Church Street between North and South Main Streets.

Date: Friday, August 31, 2018

Time: 5:30 p.m. to close the remaining two lanes of Church Street between North and South Main Streets; close North Main Street from Hwy 903 to Roanoke Avenue; close Spring Street between North Main Street and Center Street; and close Church Street from North Main Street to the first residence.

Date: Saturday, September 01, 2018

Time: 8:00 a.m. to close Ferguson Street from South Main Street to the intersection of Halifax Street, reopening at 5:00 p.m. All remaining streets will reopen at 6:00 p.m.

(B) This ordinance to become effective when signs are erected giving notice of the limits and times of the celebration, and implementation of adequate traffic control to guide through vehicles around the celebration area.

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

70.01 General Provisions

(A) The Board of Commissioners of the Town of Littleton pursuant to the authority granted by G.S. 20-169 does hereby declare a temporary road closure during the date and time set forth below on the following described portion of a State Highway System route:

Date: June 30, 2018

Time: 10:00 a.m. to 11:00 p.m.

Route Description: Mosby Avenue at Lakeland Cultural Arts Center turning onto Hwy 158 at the traffic light proceeding east and ending at the industrial building parking lot on Hwy 158.

(B) This ordinance to become effective when signs are erected giving notice of the limits and times of the celebration, and implementation of adequate traffic control to guide through vehicles around the celebration area.

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.
